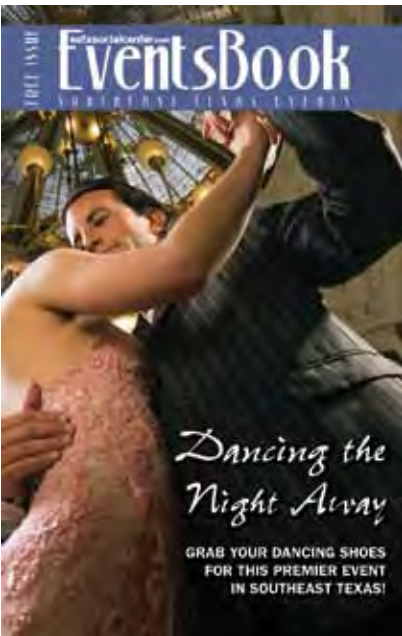

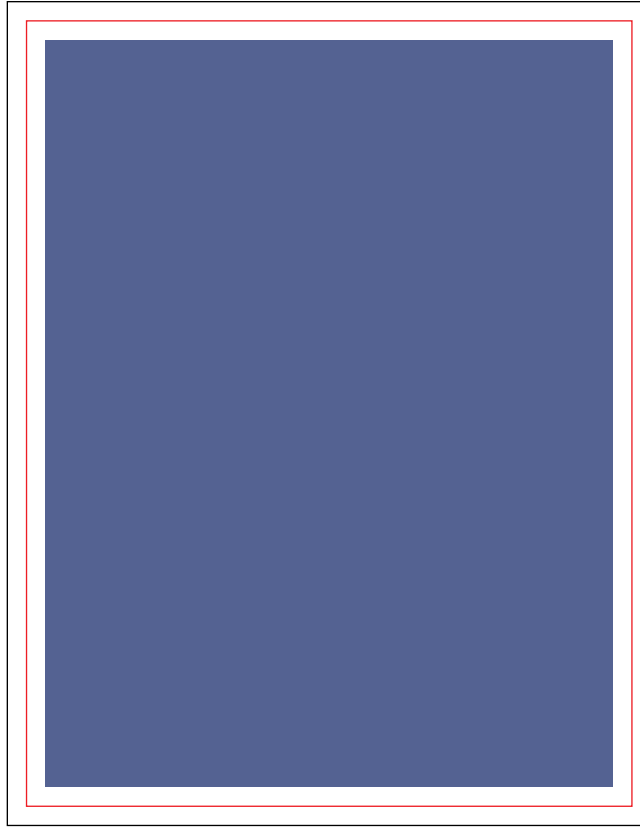

ORGANIZATION TERMS AND CONDITIONS

SIGNED CONTRACT

Contracts for promotional packages for organizations must be completed, signed and delivered on or before the promotional package begins and goes online. Once the promotional package contract is signed and materials are received, the package will go online no later than 15 days past the date of the contract and receipt of materials. All promotional materials must be approved prior to going live by the organizational contact person. Changes to the promotional campaign will be accepted and made within 48 hours of receipt of changes and/or edits. Ad placement on E-Centered is subject to SETXSocialcenter.com discretion unless placement is specified and paid for.

PAYMENT TERMS

Payment is due upon the date of the contract and prior to any promotional materials going live. Agent and agency discounts are given to online and print advertising. There is no agent or agency discount for membership fees. Organizations who do not run the contracted promotion will be re-billed at the earned frequency rate using the current rate card immediately following the cancellation or curriculum of space frequency contracted. Organization agrees that in the event of default in the payment due for any purchase, or in the event of default in the payment of the contractual terms on any account, according to the terms hereof, all expenses of collection, with or without court action, including a reasonable attorney fee, shall be paid by the organization.

COPY AND CONTRACT REGULATIONS

Liability claims arising from content of promotional materials (text, representation and illustrations) are assumed by organization. Organization agrees to indemnify, defend and hold harmless SETXSocialcenter.com its officers, agents and employees against expenses, including legal fees, resulting from the publication of the content of the promotional materials, and to hold it harmless from any claims or demands arising from any materials submitted by the organization, including without limitation, claims or suits for libel, violation of right of privacy, copyright and trademark infringements, business disparagement, and defamation or plagiarism.
