signed contract

payment terms

Payment is due upon the date of the contract and prior to any promotional materials going live.

There is no agent or agency discount.

Organizations who do not run the contracted promotion will be re-billed at the earned frequency rate using the current rate card immediately following the cancellation or curriculum of space frequency contracted.

Organization agrees that in the event of default in the payment due for any purchase, or in the event of default in the payment of the contractual terms on any account, according to the terms hereof, all expenses of collection, with or without court action, including a reasonable attorney fee, shall be paid by the organization.

copy and contract regulations
